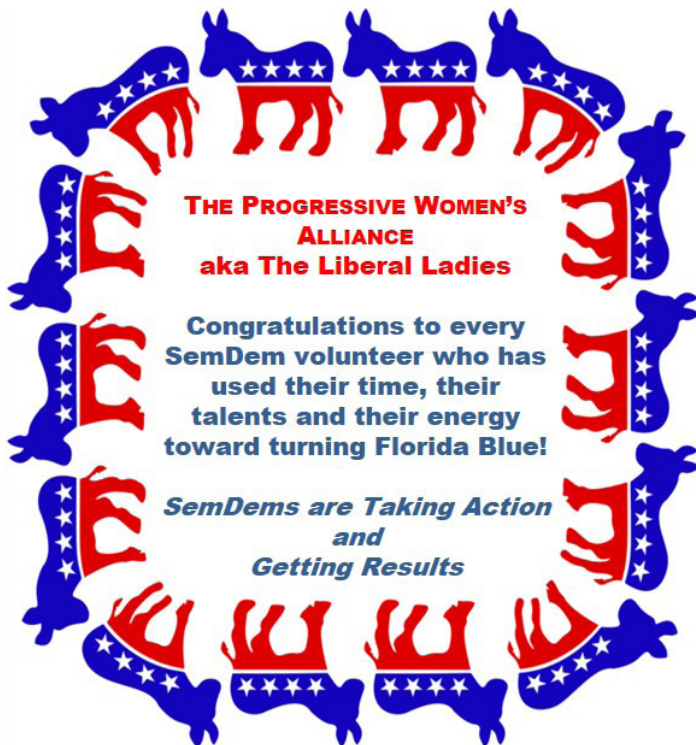

In 2008, Senator Bill Nelson addressed an audience of 4-H and FFA members at the Florida State Fair.

He said, “Today, we need more young people who understand the tremendous impact that community and public service can have in our troubled world . . . I feel a great sense of optimism when I meet young people with the potential and desire to make a difference in everyday life.”

From day one, Senator Bill Nelson walked his talk. As one who got involved, served, led. As one who got things accomplished from an early age. As a leader during his high school years in Melbourne and throughout college at the University of Florida, Yale and the University of Virginia.

Senator Nelson served in public office from 1972 through 2019, including the Florida House of Representatives (1972-78), the U.S House of Representatives (1979-1991), Florida State Treasurer and Insurance Commissioner (1995-2000) and finally as U.S. Senator from 2000-2019.

During his storied career, he participated as a crew member on the twenty-fourth flight of the Space Shuttle Columbia, January 12-18, 1986. He supported same-sex marriage. Nelson backed lowering taxes on lower and middle-income families. He advocated for expanding America’s environmental programs and protected the Affordable Care Act as well as backed the expansion of Medicaid.

Senator Nelson’s closing remarks in 2008 to the FFA and 4-H members were, “I suggest that your life will be fruitless unless occasioned with unrewarded acts of kindness and love. The highest form of leadership is a servant leader. Our state and our country are counting on you, counting on you to do the good thing. And don’t ever be afraid to try.”

These words inspire.

Senator Nelson has been here for Florida and for America.

We’ve counted on Bill Nelson and time and time again, he’s delivered. His legacy is an inspirational to us all.

Thank you, Senator Nelson.

WANTED!

POLL WATCHERS FOR SEMDEMS 2020 PRESIDENTIAL ELECTION

A poll watcher is a registered voter designated by SemDems to watch and observe the conduct of an election:

- Report suspected violations to clerk of the precinct or the election board
- Observe the opening of the polling station with empty ballot boxes
- Observe the closing and counting of ballots.
- Observe the distribution of ballots to voters
- Observe the deposition of ballots into the ExpressVote machines
- Count voters
- Check voting list for who has voted

SemDems may have 1 poll watcher at a time (shifts available) and must submit names to the Supervisor of Elections 14 days in advance of an election.
